Her current research focuses on the development and analysis of multidimensional frameworks of indicators to measure and compare the performance of healthcare services and healthcare systems at the local and regional levels. Specifically, she coordinates the oncological pathway performance evaluation for Regione Toscana and the Italian Regional Performance Evaluation System and is scientific responsible for the analysis of the territorial cancer model introduced in Toscana for hospital-territorial continuity of care. She applies data driven analysis to measure pathways performance and assess managerial improvements and optimization of care services.
