### Job Position

Sant'Anna School for Advanced Studies announces a public selection call based on qualifications and competitive exams for one technology expert, following art. 24-bis L. 240/2010; the contract will run for 24 months, with placement in D grade, economic position D3, at the Institute of Management of Sant'Anna School for Advanced Studies. This role will provide both technical and managerial support to the project SoBigData.it: "Strengthening the Italian RI for Social Mining and Big Data Analytics".

### Main duties and activities

As part of the research activities funded through the National Recovery and Resilience Plan (PNRR), supported by the European NextGenerationEU programme, the School needs a professional figure capable of providing both administrative and technical support to the project. The successful candidate will deal with the management of research in the field of commercial evaluation and development of business models for the long-term sustainability of the Research Infrastructure for social data experiments promoted by the Sobigdata.it project, with data collection activities, case studies and good practices.

Skills in business models and/or familiarity with technologies and areas related to Big Data are particularly relevant to the selection process, although not exclusive.

### Admission Requirements

Applicants must hold:

- Bachelor's degree in Business Administration or Computer Engineering or Computer Science or Computer Security or Economics or Engineering Management.
- At least two years (also if not continuous) of documented job experience in pertinent fields.
- Excellent knowledge of both English and Italian language.
- In order to work in Italy as public employees, non-EU citizens need a long-term residence permit or the status of refugee or otherwise in need of international protection, i.e. the subsidiary protection status pursuant to Legislative Decree n° 251/2007 or the status of family member of the holder of subsidiary protection status present in the Italian national territory pursuant to art. 22, paragraphs 2 and 3 of Legislative Decree n° 251/2007 (specifying in the application the relevant residence permit).
