

CALL FOR TWO TECHNOLOGY EXPERTS Institute of Law, Politics and Development Sant'Anna School for Advanced Studies – Pisa

#### **Job Position**

The Sant'Anna School for Advanced Studies announces a public selection call based on qualification and competitive exams for two technology experts, following art. 24-bis L. 240/2010; the contracts will run for 20 months, with placement in EP grade, economic position EP1. These roles will provide both technical and managerial support to the project: "BRIEF - Biorobotics Research and Innovation Engineering Facilities".

#### Main duties and activities

As part of the research activities funded through the National Recovery and Resilience Plan (PNRR), supported by the European NextGenerationEU programme, the School needs two professional figures capable of providing both administrative and technical support to the project.

The first figure will contribute to the development of innovative solutions in the use and enhancement of legal data and, in particular, he/she shall provide assistance in the enhancement of personal and non-personal data with the use of methods of Natural Language Processing and Machine Learning; moreover, he/she shall provide technical support to the development of innovative solutions in the use and enhancement of data. This figure shall therefore use and manage a plurality of data contributing to the design and development of an integrated platform dedicated to the storage, consultation, sharing, analysis and enrichment of legal data, as well as to the ideation, design and development of pseudonymisation and anonymisation solutions for personal data.

The second figure shall design understandable, usable and compliant communications, including views on the topic of privacy, the design of interfaces for consensus and usable and transparent rights, etc., as well as design empirical studies (questionnaires, interviews, participatory workshops) and carry out the related qualitative analysis of data, such as on the interaction with technologies impacting on privacy, always as part of the research activities related to BRIEF in synergy with the relevant WP. He/She will also provide assistance in legal research on BRIEF issues, with particular reference to the protection and governance of personal data.

### **Admission Requirements**

- Master's degree.
- At least five years (also if not continuous) of documented job experience in pertinent fields.
- Excellent knowledge of both English and Italian language.
