Open Call for Expression of Interest – Tenured Position of recognized researcher (R2)

The protection of the fundamental right to health, the regulation of health systems and the management of the legal risks derived from technological and scientific innovations in the medical, biomedical and epidemiological fields require a local/national/transnational and European legal framework for the implementation of ethical and legal good practices in everyday action (e.g., enable an holistic approach to the right to an effective access to health as an individual and a collective interest in a multilevel perspective and promoting technical solutions compliant with the ethical-regulatory framework by design). In the attempt to strengthen its research, teaching and Third Mission capacity at a local, national and international level the [DIRPOLIS Institute](#) and the [Interdisciplinary Research Center "Health Science"](#) are planning to open a tenure track position (RTT Researcher becoming Associate Professor after 3 or 6 years upon confirmation) to support the development of the response capacity to the aforementioned regulatory needs.

Profile. We are looking for a legal expert in issues related to one or more of the following fields of interest:

- **Health law in the local, domestic, European, international and comparative dimension,**
- **The right to health and to an effective access to care services and its impact on the organization of the health care system including also the social perspective**
- **Management and protection of Personal data with special reference to the health-related ones,**
- **The legal framework of the regulation, the development and the integration of public and private providers, profit and no profit, in the universal coverage healthcare system contest**
- **Liability in health sector and regulation of drugs or medical devices,**
- **Bioethical profiles of medical experimentation (also related to robotic and implantable medical devices) and ethical and legal issues in personalized medicine,**
- **Definition and implementation of the LEA- Essential Levels of Assistance for health and social services**

The applicant should have a proven track of interest and expertise in one or more of the above mentioned fields. Strong written and verbal communication skills are required at least in English. Preference will be given to candidates with recent and relevant hands-on experience with applied research and academic leadership experience including for instance the ability to apply successfully for competitive research funds at national and international level. Activities to be performed. The successful applicant will be required to teach, advise and mentor undergraduate and graduate students, develop an independent, externally funded research program,

contribute to the ongoing research programmes and training activities, actively participate in all aspects of the Institute and of the Scuola Sant'Anna activities.

Terms and Conditions. The starting gross salary for a tenure track Assistant Professor in public Italian universities is € 44.207. The severance pay is equal to one month of gross salary for each year of employment. As employer, the Sant'Anna School pays contributions to both the Italian social security and the Italian public health systems. Individuals who have conducted at least two years of research abroad may also qualify for a temporary reduced taxation regime (pursuant art. 44 of Italian Law 78/2010, taxation may be restricted to 10% of their Italian income for a period ranging from 5 to 12 years, depending on their family status).
