

Summary of the Rector's Decree no. 551 of 28,07,2023

CALL FOR APPLICATIONS FOR TWO TENURE TRACK - PROBATIONARY ASSISTANT PROFESSOR POSITIONS

The Sant'Anna School of Advanced Studies - Pisa (Sant'Anna School) announces a call for the recruitment of **two tenure-track – probationary**, **assistant professor** (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 at the Academic Faculty of Social Sciences and:

Departement of Exellence "Economics, Management and the Law in the era of Data Science" - L'EMbeDS

One position in the Academic Recruitment Field "Demography and Social Statistics" (SC 13/D3) – Academic Discipline "Social Statistics" (SSD SECS-P/05).

Research activities: The successful candidate will carry out research activities in the domains that characterize the academic discipline of Social Statistics, with particular reference to the application and development of statistical methodology for the design and evaluation of healthcare needs, services and interventions. Specifically, (s)he will deal with the analysis of health-related phenomena using conventional statistical models and/or machine learning techniques applied to data of various types and origin, including big data. The successful candidate is also expected to contribute to the training, organizational and institutional activities of the Department of Excellence, of the Institute and/or Center of affiliation, and of the University.

Institute of Law, Politics and Development - DIRPOLIS

One position in the Academic Recruitment Field "Criminal Law" (SC 12/G1) – Academic Discipline "Criminal Law" (SSD IUS/17).

Research activities: The successful applicant will be required to develop a high impact publications plan and an independent and externally funded applied research program, contribute to the ongoing research and life-long training programmes in Italian and English.Research activities should focus on the following domains: Corporate Compliance and Enforcement in the domestic and crossborder dimension, Public and private corruption, Economic crimes and criminal risk management, the legal framework of the prevention and fight of organized crime, the transformation of criminal responsibility in the new metaregulatory scenarios, the criminal profiles of climate change and sustainability, Global criminal governance, Criminal Law Jurisdiction Pluralism and Legal Space Theory. The successful applicant will be also required to actively contribute to the life of the Institute and the Scuola Sant'Anna including teaching, advisor and mentoring activities for undergraduate, graduate and PhD students and contribute to the SSSA Third Mission plan. The assistant professor will also contribute to teaching activities within the Scuola Superiore Sant'Anna teaching programs (Undergraduate, Master, Seasonal Schools and and Ph.D. students), also delivered in English.

Candidates can submit no more than 12 publications.



Duration of the contracts: six years.

Terms and conditions of employment: in his/her sixth year Assistant Professor who have received from Italian Ministry of University and Research, the appropriate qualification ("abilitazione nazionale") and eligibility for promotion, according to Law no. 240/2010, art. 16, at the rank of Associate Professor or higher, will be evaluated by Sant'Anna School Committee, pursuant Ministerial Decree no. 344/2011, for possible promotion to tenured positions by the end of that period.

<u>Salary:</u> \in 40.524 gross per year (since year 1 to year 3), \in 44.208 gross per year (since year 4 to year 6).

Admission Requirements:

Candidates must satisfy the following requirements:

- to hold a PhD or equivalent. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide the documents which certify that these qualifications are considered equivalent according to the Italian law in force (equipollence/equivalence-recognition of degrees)¹;
- to have an excellent knowledge of both written and spoken English.

Who Can't Apply

- Those who, at the date of the deadline for application, are or have been professors or assistant professors who achieved tenure.
- Those Who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage to professors of Sant'Anna School of the Academic Faculty of Social Science, or to the Rector (Rettore) or to the Managing Director (Direttore Generale), or to a member of the Academic Senate (Senato Accademico) or of the Board of Directors (Consiglio di Amministrazione) of Sant'Anna School.

- 2) Copy of Identification Document (e.g. passport);
- 3) Copy of your PhD thesis;
- 4) Copy of your publications, not exceeding the number above indicated and list of the submitted publications;
- 5) all academic and professional qualifications, other accomplishments, awards and any additional information which can be useful for the evaluation of the applicant. All documents, certificates and letters submitted should be saved in .pdf format;
- 6) a proposal for a research project (max no. 4 pag. for SC 13/D3) that the candidate proposes to carry out as part of the research activities defined in the call.

To apply candidates need have a mail address, a printer and a scanner because they have to print, sign and upload the scanned copy of the application.

They will be able to withdraw their application until the deadline, Id they need to change a submitted application, they have to withdraw it and submit a new one.

Selection process and calendar:

The evaluation committee will be appointed by the Rector of the Scuola Sant'Anna. A restricted number of applicants, to be admitted to a final interview, will be selected by the committee, on the basis of cv's, publications and qualifications.
