

Summary of the Rector's Decree n. 367 of May, 31, 2023

## CALL FOR APPLICATIONS FOR no. THREE TENURE TRACK - PROBATIONARY ASSISTANT PROFESSOR POSITIONS

The Sant'Anna School of Advanced Studies - Pisa (Sant'Anna School) announces a call for the recruitment of <u>three tenure-track – probationary</u>, <u>assistant professors</u> (ricercatori a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter B in the frame of the Department of Excellence Robotics & I.A. at the Academic Faculty of Experimental and Applied Sciences in the:

#### **INSTITUTE OF BIOROBOTICS**

One position in the Academic Recruitment Field "BIOENGINEERING" (SC 09/G2) – Academic Discipline "Electronic and Informatic Bioengineering" (SSD ING-INF/06).

The researchers will have to carry out research activities that are characterized by a quality aligned with international standards in the field of bioengineering, in line with the areas of activity of the Institute of BioRobotics and the objectives of the Department of Excellence in Robotics & Artificial Intelligence.

In particular, the Candidate will have to enhance the activities related to the development of wearable and implantable systems to restore sensory-motor functions in people with disabilities and to the development of innovative algorithms for the analysis of signals taken from the central and peripheral nervous system. The goal is to increase translational activities in bioelectronics and neuroengineering by favoring the connection between preclinical and clinical experiments by also enlarging the network of existing collaborations.

# COMMUNICATION, COMPUTER ENGINEERING, AND PHOTONICS INSTITUTE (TECIP)

 Two positions in the Academic Recruitment Field – "TELECOMMUNICATIONS" (SC 09/F2) – Academic Discipline "TELECOMMUNICATIONS" (SSD ING-INF/03).

The Assistant Professors have to carry out high-quality research according to international quality standards in the field of telecommunications engineering and photonics, in coherence with the areas of activity of the TECIP Institute and the objectives set out by the Department of Excellence in Robotics and AI, in particular to enhance the research capabilities of the following two research areas:

- 1. Networks and Services, with special focus on the following topics: Optical network softwarization, Network acceleration techniques, Al-based network automation, Optical transport for B5G and 6G mobile radio access, 3D Networking.
- 2. Microwave Photonics, with special focus on the following topics: photonics for the B5G/6G radio access, Integrated photonics for remote sensing, mm-Wave systems, All-optical processing for B5G/6G systems, Integrated photonics and packaging for space applications.

Candidates can submit no more than 12 publications.

The assistant professors will contribute to teaching activities within the Scuola Superiore Sant'Anna teaching programs (Undergraduate, Master, Seasonal Schools and Ph.D. students), also delivered in English.

**Duration of the contracts:** three years.



Terms and conditions of employment: in his third year Assistant Professors who have received from Italian Ministry of University and Research, the appropriate qualification ("abilitazione") and eligibility for promotion, according to Law no. 240/2010, art. 16, at the rank of Associate Professor or higher, will be evaluated by Sant'Anna School Committee, pursuant Ministerial Decree no. 344/2011, for possible promotion to tenured positions by the end of that period.

Salary: 44.208 € gross per year

#### **Admission Requirements:**

#### Candidates must satisfy the following requirements:

- to hold a PhD or equivalent. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide the documents which certify that these qualifications are considered equivalent according to the Italian law in force (equipollence/equivalence-recognition of degrees). If candidates do not comply with the requirement while submitting the application, they will be admitted to the selection under condition and, if winners, they have to submit all necessary documents certifying that their qualifications are considered equivalent according to the Italian law in force by the date of the signature of the contract<sup>1</sup>.
- to have achieved the Italian appropriate qualification ("abilitazione nazionale") received by the Ministry of University and Research, according to art. 16 of Law no. 240/2010, at the rank of Associate or Ordinary Professor or to have been employed for at least three years, even if not consecutive, as non tenured assistant professor or as research fellow or as postdoctoral fellow. The contracts, if obtained by Italian Universities, must have been subscribed pursuant to art. 1, paragraph 14 of Law 230/2005 or pursuant to art. 24 paragraph 3 letter a) of Law 240/2010 or pursuant to art. 51 paragraph 6 of Law 449/97 and amendments or pursuant art. 22 of law 240/2010 or pursuant to art. 4 of Law 398/89. Validity and equivalence requirements of contracts obtained by non-Italian Universities will be evaluated by Sant'Anna School Evaluation Committee.
- to have an excellent knowledge of both written and spoken English.

#### Who Can't Apply

- Those who, at the date of the deadline for application, are or have been professors or assistant professors who achieved tenure.
- Those Who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage to professors of Sant'Anna School, or to the Rector (Rettore) or to the Managing Director (Direttore Generale), or to a member of the Board of Directors (Consiglio di Amministrazione) of Sant'Anna School.
