Concept

In the EU, the 2022 wildfire season witnessed a 250% increase in the average burnt area. Since the year 2000, the percentage of the global population exposed to flooding has risen by nearly a quarter. These figures highlight the rapid escalation of disaster risk, with scientific projections indicating a continued steady increase due to the impacts of climate change. Furthermore, massive and complex events, such as the COVID-19 pandemic or the conflict between Russia and Ukraine, are exerting additional pressure on our societies. Therefore, establishing a **legal and institutional framework for effective disaster prevention, preparedness, and mitigation activities, including cross-border humanitarian assistance**, is increasingly necessary to manage disasters and other events that surpass national response capacities.

The first workshop organized as part of the EU Horizon project EUMA (Creating a European Higher Education Network for MAster's Programmes in Disaster Risk Management) network's education strategy will delve into these topics. This one-and-a-half day, discussion-based workshop will explore the international legal framework dealing with disasters and conflicts, as well as institutional and operational aspects related to the EU Civil Protection Mechanism and other international disaster management systems. The workshop, conducted in a hybrid format, will be open to roughly 20 participants, primarily targeting disaster management professionals, but also welcoming representatives from EUMA partner institutions. It aims to provide valuable input for the future phases of the project.
