

## **CALL FOR ONE TECHNOLOGY EXPERT**

Sant'Anna School for Advanced Studies - Pisa

#### **Job Position**

The Sant'Anna School for Advanced Studies announces a public selection call based on qualifications and competitive exams for one technology expert, following art. 24-bis L. 240/2010; the contract will run for 26 months, with placement in EP grade, economic position EP1. This role will provide both technical and managerial support to the project: "Fit4MedRob – Fit for Medical Robotics", financed under the National Investment Plan (PNC) complementary to the PNRR (NextGeneration EU).

#### Main duties and activities

Fit for Medical Robotics aims to revolutionise current rehabilitation and assistive models for people of all ages with reduced or absent motor, sensory, or cognitive functions, by means of novel (bio)robotic and allied digital technologies and of continuum of care paradigms that can take advantage of the novel technologies in all the phases of the rehabilitation process, from the prevention up to the home care in the chronic phase.

In this context, the selected person shall support the scientific direction and the monitoring in various areas of the Initiative, in close collaboration with the Scientific Director and the Programme Manager; moreover, the figure being sought shall supervise the planned technical-scientific activities, including the reporting ones, whose correctness and consistency with deliverables must be ensured, in order to achieve targets and timing.

## **Admission Requirements**

Applicants must hold:

- Master's degree in Biomedical Engineering.
- At least five years (also if not continuous) of documented job experience in pertinent fields.
- Excellent knowledge of English and good knowledge of Italian.
- In order to work in Italy as public employees, <u>non-EU citizens</u> need a long-term residence permit or the status of refugee or otherwise in need of international protection, i.e. the subsidiary protection status pursuant to Legislative Decree n° 251/2007 or the status of family member of the holder of subsidiary protection status present in the Italian national territory pursuant to art. 22, paragraphs 2 and 3 of Legislative Decree n° 251/2007 (specifying in the application the relevant residence permit).
