## **CALL FOR APPLICATION FOR ONE ASSISTANT PROFESSOR POSITION**

The Sant'Anna School of Advanced Studies .- Pisa (Sant'Anna School) announces a call for the recruitment of **one assistant professor** (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter A at the Academic Class of Social in the **Academic Recruitment Field Economic Policy (SC 13/A2) – Academic Discipline Economic Policy (SSD SECS-P/02) at the Institute of Economics for the activities of the EMbeDS Department of Excellence (Economics and Management in the Era of Data Science)**

The selected candidate will conduct high profile research meeting the most demanding international standards. This will concern development of computational agent-based models (including also the analysis of the effects of technical progresses on climate change and environmental sustainability) and the calibration and empirical validation of agent-based economic models.

The researcher's activity will take place in the fields of 'economies as complex evolving systems' and 'environmental and social sustainability' that will be conducted by the Institute of Economics in the framework of the EMbeDS Department of Excellence (Economics and Management in the Era of Data Science, see <http://embeds.santannapisa.it/>). The researcher must therefore demonstrate a good attitude towards teamwork on broad research projects, involving the combined use of analytical and computational tools for the analysis of economic systems using agent-based models.

The successful candidates will also teach at the undergraduate (allievi ordinari), Masters (allievi Laurea Magistrale) and doctoral (allievi perfezionandi/PhD, alta formazione) levels – both in the School and in its federated institutions: Istituto Universitario di Studi Superiori di Pavia and Scuola Normale Superiore di Pisa.

**Duration of the contracts:** three years.

**Salary:** 34.898,06 € gross per year.

### **Admission Requirements:**

**Candidates must satisfy the following requirements:**

- to hold a PhD or equivalent. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide the documents which certify that these qualifications are considered equivalent according to the Italian law in force (equipollence/equivalence-recognition of degrees). If candidates do not comply with the requirement while submitting the application, they will be admitted to the selection under condition and, if winners, they have to submit all necessary documents certifying that their qualifications are considered equivalent according to the Italian law in force by the date of the signature of the contract<sup>1</sup>.

- Those who, at the date of the deadline for application, are or have been professors or assistant professors who achieved tenure.
- Those who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage or by civil union or are married to professors of Sant'Anna School, or to the Rector ( Rettore) or to the Managing Director (Direttore Generale), or to a member of the Board of Directors (Consiglio di Amministrazione) of Sant'Anna School.

  - copy of your publications, **not exceeding the number of 12**;
  - copy of your PhD thesis;
  - a list of the documents attached, signed and dated;
  - -a self-declaration stating authenticity and truthfulness of any submitted documents (Attach 1);
  - a proposal of a research project focused on the study of the impact of climate change on macroeconomic dynamics from a theoretical and empirical perspective. At the theoretical level is required the use of heterogeneous and interacting agent models.
