



Summary of the Rector's Decree nr 256 of May, 9, 2019

CALL FOR APPLICATIONS FOR ONE TENURE TRACK - PROBATIONARY ASSISTANT PROFESSOR POSITION

The Scuola Universitaria Superiore Sant'Anna (Sant'Anna School) announces a call for the recruitment of **one tenure-track (probationary) Assistant Professor** (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter B, **in the Academic Recruitment Field Informatics (01/B1 Informatica) – Academic Discipline Informatics (INF/01 Informatica)**. The Assistant Professor will join the **Institute of Economics**, as part of the activities of the **EMbeDS Department of Excellence** (*Economics and Management in the Era of Data Science*).

The successful candidate will perform high profile research, adhering to the highest international standards, developing algorithms and quantitative methods for the analysis of complex systems and big data – with a particular focus on their application to the study of economic and social systems. His/her research will be integral to at least one of the four research themes pursued by the Institute of Economics within the framework of the EMbeDS Department of Excellence: (i) 'innovation and the 4th industrial revolution'; (ii) 'industrial dynamics, competitiveness and financial markets'; (iii) 'economies as evolving complex systems'; and (iv) 'social and environmental sustainability'. The successful candidate will therefore demonstrate an ability to work as part of a team tackling broad and interdisciplinary projects.

Candidates can submit no more than 12 publications.

Duration of the contract: three years.

Terms and conditions of employment: during the third year, provided the Assistant Professors has obtained the "abilitazione nazionale" at the rank of Associate or Full Professor, as granted by the Ministry of Education, University and Research according to art. 16 of Law no. 240/2010, and eligibility for promotion, he/she will be evaluated by a committee of the Sant'Anna School, pursuant Ministerial Decree no. 344/2011, for possible promotion to an Associate Professor tenured position.

Salary: 41.878,00 € gross per year

Admission Requirements:

Applicants must satisfy the following requirements:

- Hold a PhD or equivalent qualification. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide documentation certifying that the degree or qualification is accepted under current Italian law (equipollence/equivalence-recognition of degrees). If individuals do not submit such documentation at the time of their application, they will be considered and evaluated conditionally; if an individual is selected for the position, he/she will be required to submit the documentation by the date on which his/her contract with the Sant'Anna School is signed¹.

- Hold the Italian “abilitazione nazionale” at the rank of Associate or Full Professor, as granted by the Ministry of Education, University and Research according to art. 16 of Law no. 240/2010; or to have been employed for at least three (not necessarily consecutive) years, as a non-tenure track Assistant Professor, Research Fellow or Postdoctoral Fellow. The contracts for such positions, if obtained by Italian Universities, must have been subscribed pursuant to art. 1, paragraph 14 of Law 230/2005; or pursuant to art. 24 paragraph 3 letter a) of Law 240/2010; or pursuant to art. 51 paragraph 6 of Law 449/97 and amendments; or pursuant art. 22 of law 240/2010; or pursuant to art. 4 of Law 398/89. Validity and equivalence requirements of contracts obtained by non-Italian Universities will be evaluated by the Sant’Anna School Evaluation Committee.
- Have an excellent knowledge of both written and spoken English.

Who Cannot Apply

- Those who, at the date of the application deadline, are or have been professors or assistant professors who achieved tenure.
- Those who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage to any professor of the Sant’Anna School, or to the Rector (Rettore), the Managing Director (Direttore Generale) or any member of the Board of Directors (Consiglio di Amministrazione) of the Sant’Anna School.

 - A list of all submitted documents, signed and dated;
 - A self-declaration of authenticity and accuracy of all submitted documents (Attachment 1);
 - A self-declaration that the applicant fulfills all admission requirements (Attachment 2);
 - **A research proposal describing the** research activity that the applicant intends to carry on, in relation to the profile described above).
