

Summary of the Rector's Decree no. 346 of June, 9, 2020 CALL FOR APPLICATIONS FOR TWO ASSISTANT PROFESSOR POSITION

The Sant'Anna School of Advanced Studies .- Pisa (Sant'Anna School) announces a call for the recruitment of <u>two assistant professors</u> (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter A at the Academic Class of Social Sciences at the Institute of Management:

- one in the Academic Recruitment Field "Business Administration and Accounting Studies" (SC 13/B1 "Economia Aziendale") – Academic Discipline "Business Administration and Accounting Studies" (SSD SECS-P/07 "Economia Aziendale);
- one in the Academic Recruitment Field "Demography and social statistics" (SC 13/D1 "Demografia e Statistica Sociale") - - Academic Discipline "Social Statistics" (SSD SECS-S/05 "Statistica Sociale")

Position in Business Administration and Accounting Studies

Research activities: The successful candidate will work on developing a multidimensional performance measurement system for the public sector, especially the healthcare sector, using big databases generated from administrative flows and surveys distributed to patients and civil servants. The activity will be complementary to research on the support for decisions in healthcare undertaken by the Health Area of the Institute of Management within the scope of the Department of Excellence EMbeDS (http://embeds.santannapisa.it).

Position in Demography and social statistics

Research activities: The successful candidate will be required to conduct research in the field of statistics and of its applications in to social, economic and business research areas. He/She will also apply statistical and data science methods for the analysis of large data sources in support of decision-making for environmental, innovation and healthcare management in the framework of the Department of Excellence EMbeDS (http://embeds.santannapisa.it).

<u>Didactic activities</u>: The successful candidates will also teach at the undergraduate (allievi ordinari), Masters (allievi Laurea Magistrale) and doctoral (allievi perfezionandi/PhD, alta formazione) levels – both in the School and in its federated institutions: Istituto Universitario di Studi Superiori di Pavia and Scuola Normale Superiore di Pisa.

Duration of the contracts: three years.

Salary: 35.733 € gross per year.

Admission Requirements:

Candidates must satisfy the following requirements:

 to hold a PhD or equivalent. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide the documents which certify that these qualifications are considered equivalent according to the Italian law in force (equipollence/equivalence-recognition of degrees). If candidates do not comply with the requirement while submitting the application, they will be admitted to the selection under condition and, if winners, they have to submit all necessary documents certifying



that their qualifications are considered equivalent according to the Italian law in force by the date of the signature of the contract¹.

• to have an excellent knowledge of both written and spoken English.

Others Requirements

Candidates must supply:

- their PhD thesis
- no more than 12 publications

Who Can't Apply

- Those who, at the date of the deadline for application, are or have been professors or assistant professors who achieved tenure.
- Those who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage or by civil union or are married to professors of Sant'Anna School, or to the Rector (Rettore) or to the Managing Director (Direttore Generale), or to a member of the Board of Directors (Consiglio di Amministrazione) of Sant'Anna School.
