



*Summary of the Rector's Decree nr 39 of January,24, t 2019*

**CALL FOR APPLICATIONS FOR TWO TENURE TRACK - PROBATIONARY ASSISTANT PROFESSOR POSITIONS**

The Sant'Anna Scuola Universitaria Superiore Pisa (Sant'Anna School) announces a call for the recruitment of **two tenure-track – probationary, assistant professors** (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter B at the following **Institutes**:

**Institute of Communication, Information and Perception Technologies (TECIP)**

**One Position in Academic Discipline Experimental physics of Matter (02/B1 Fisica Sperimentale della materia) – Academic Discipline Experimental physics (FIS/01 Fisica Sperimentale).**

The selected candidate will perform research activities on “*Development of advances photonic sensors, based on discrete components as well as on photonic integration, and their integration in complex materials for applications in industrial sectors including energy, automotive, transport and aerospace applications. Also chemical, environmental and biomedical photonic sensors will be studied*”. Teaching activities are also expected.

*Candidates can submit no more than 12 publications*

**Institute of Law, Politics and Development (DIRPOLIS):**

**One position in the Academic Recruitment Field Private Law (SC 12/A1 Diritto privato) – Academic Discipline Privat Law (IUS/01 Diritto privato).**

The research and teaching activities should focus on private law issues, and their relationship with the cultural, economic and technological challenges of modern society. In terms of methodology, a strong interdisciplinary approach is needed in order to carry out the research, together with an attention to the legal dynamics underpinning the European and the global governance. Teaching activity is also required.

**Duration of the contracts:** three years.

**Terms and conditions of employment:** in his third year Assistant Professors who have received from Italian Ministry of Education, University and Research, the appropriate qualification (“abilitazione”) and eligibility for promotion, according to Law no. 240/2010, art. 16, at the rank of Associate Professor or higher, will be evaluated by Sant'Anna School Committee, pursuant Ministerial Decree no. 344/2011, for possible promotion to tenured positions by the end of that period.

**Salary:** 41.878,00 € gross per year

**Admission Requirements:**

**Candidates must satisfy the following requirements:**

- to hold a PhD or equivalent. If the PhD degree or equivalent qualification has been awarded abroad, candidates must provide the documents which certify that these qualifications are considered equivalent according to the Italian law in force (equipollence/equivalence-recognition of degrees). If candidates do not comply with the requirement while submitting the application, they will be admitted to the selection under condition and, if winners, they have to



submit all necessary documents certifying that their qualifications are considered equivalent according to the Italian law in force by the date of the signature of the contract<sup>1</sup>.

- to have achieved the Italian appropriate qualification (“abilitazione nazionale”) received by the Ministry of Education, University and Research, according to art. 16 of Law no. 240/2010, at the rank of Associate or Ordinary Professor or to have been employed for at least three years, even if not consecutive, as non tenured assistant professor or as research fellow or as postdoctoral fellow. The contracts, if obtained by Italian Universities, must have been subscribed pursuant to art. 1, paragraph 14 of Law 230/2005 or pursuant to art. 24 paragraph 3 letter a) of Law 240/2010 or pursuant to art. 51 paragraph 6 of Law 449/97 and amendments or pursuant art. 22 of law 240/2010 or pursuant to art. 4 of Law 398/89. Validity and equivalence requirements of contracts obtained by non-Italian Universities will be evaluated by Sant'Anna School Evaluation Committee;
- to have an excellent knowledge of both written and spoken English.

## Who Can't Apply

- Those who, at the date of the deadline for application, are or have been professors or assistant professors who achieved tenure.
- Those who, at the date of the application deadline, are related, within the fourth degree, by blood or by marriage or by civil union or are married to professors of Sant'Anna School, or to the Rector ( Rettore) or to the Managing Director (Direttore Generale), or to a member of the Board of Directors (Consiglio di Amministrazione) of Sant'Anna School.

  - copy of your PhD thesis;
  - a list of the documents attached, signed and dated;
  - -a self-declaration stating authenticity and truthfulness of any submitted documents (Attach 1);
  - a self-declaration stating you fulfill the admission requirements (Attach 2);
  - a proposal of a research project related to the research activity that the assistant professors have to carry.
