**2012, 2013 e 2014**, if enrolled in the following PhD and Doctoral programs:

- PhD program in Agrobiosciences
- International Doctorate in Agrobiodiversity
- PhD program in Biomedical Research Emerging Technologies
- PhD program in Emerging Digital Technologies

**2013 e 2014**, if enrolled in the following PhD and Doctoral programs:

- PhD program in Management
- International Doctorate in Economics
- PhD program in Individual Person and Legal Protection
- PhD program in Politics, Human Rights and Sustainability

Applicants are requested to provide biographical information, date and place of birth, tax code, permanent home address and current contact information for the purposes described in the call. Applicants are required to include the title of their PhD thesis and the date of the dissertation defense. Each application must be accompanied by:

- Copy of valid (unexpired) identification document
- Curriculum vitae

Candidates for the Giovanni Spitali Prize are evaluated by the committee composed of the PhD/Doctoral programs coordinators or delegates to the evaluation committee.

The prize winners should formally accept the award within 3 days of notification. If a prize is declined, the scholarship will be awarded to the next eligible candidate in the merit list.
