### **MINUTE OF THE THIRD MEETING**

The Evaluation Committee for the selection of one assistant professor (ricercatore a tempo determinato) with full time temporary contract pursuant to Italian Law no. 240/2010, art. 24 paragraph 3 letter A, for the Academic Recruitment Field "Economic Policy" ( 13/A2) – Academic Discipline "Economic Policy" (SECS-P/02), at the Institute of Economics of Sant'Anna School of Advanced Studies – Pisa for the activities of the EMbeDS Department of Excellence (Economics and Management in the Era of Data Science), appointed by decree No. 787 dated November, 26, 2021, by the Rector, consists of:

- Prof. Andrea Mina, Associato del Settore Concorsuale 13/A2 Politica Economica at Sant'Anna School of Advanced Studies;
- Prof.ssa Valentina Tartari, Associate Professor at Copenhagen Business School;
- Prof.ssa Tania Treibich, Assistant Professor at Maastricht University.

The Committee convened for the last time, via teleconference, on 6/12/2021, at 2. P.M. from the following locations:

Prof. Mina located in Pisa at Scuola Superiore Sant'Anna, connected via Zoom from the address [andrea.mina@santannapisa.it](mailto:andrea.mina@santannapisa.it).

Prof.ssa Tartari located in Copenhagen, at Copenhagen Business School, connected via Zoom from the address [vt.si@cbs.dk](mailto:vt.si@cbs.dk).

Prof.ssa Treibich located in Maastricht, at Maastricht University, connected via Zoom from the address [t.treibich@maastrichtuniversity.nl](mailto:t.treibich@maastrichtuniversity.nl).

The draft of the following minutes was agreed upon and approved by the members of the Committee.

The Chair ascertained that all the members of the Committee were present and declared the session open. Each member of the Committee declared to have accessed online and examined the documents submitted by the candidates.

The Committee acknowledged notification that Emanuele Russo withdrew from the selection process, as communicated to the Staff Office, protocol file n. 22646, dated 6/12/2021.

The Committee then carried out a collegial examination of the documentation and drafted brief summaries of the qualifications, curricula and scientific productions of the candidates. These assessments are enclosed and form an integral part of the present minutes (Annex No. 1).

At 15 the Committee completed the examination of the documents supplied by the candidates and joined the link

published on the School website to start the public interview with the candidates.

The Committee ascertained that only one candidate, Dr. Martina Iori, joined the meeting.

The Committee noted that in addition to the candidate, no other interested party was connected.

The Chair invited the candidate to show the ID document sent with the application and positively identified the candidate.

The Committee then started the interview with Dr. Martina Iori. The interview was held in English, and the candidate's proficiency in the English language was also assessed.

At the end of the interview, after 15 minutes of wait for the remaining candidates to join the interview process, the Committee ended the public call, and continued the evaluation meeting. After a thorough debate, the Committee assigned the scores to the qualifications, to each publication submitted by the candidate, to the overall consistency of the scientific production and to the proposal, on the basis of the criteria defined in the preliminary meeting. The scores assigned are listed in Annex No. 3.

Thereafter the Committee summarised the scores assigned to the candidates.


On the basis of the scores obtained, the Committee declared Dr. Martina Iori winner of the selection.

### **CANDIDATE: DANESE Giuseppe**

The Candidate is Postdoctoral Fellow in the Philosophy, Politics and Economics Program of the University of Pennsylvania. He completed his doctoral studies in 2014 at the Department of Economics of Simon Fraser University, after obtaining an MA from the University of Trento (Dept. of Economics and Management) and an MSc from Queen Mary University in London (School of Economics and Finance). He has extensive teaching and refereeing experience. His research focuses on experimental and behavioural economics, law and economics, business economics and business ethics. He has authored several publications in journals of limited impact relative to the Call's field, and presented his work at numerous conferences. He shows satisfactory scientific productivity. The fit between the overall scientific profile and the requirements of the position is only partial. The Candidate does not present a Research Proposal.

### **CANDIDATE: IORI Martina**

The Candidate is Postdoctoral Research Fellow at the Sant'Anna School of Advanced Studies. She completed her doctoral studies in 2019 at the "Vilfredo Pareto" Economics Department of the University of Turin and Collegio Carlo Alberto. In addition to an MA in Economics (Economics and Complexity Program, Turin) she holds undergraduate and graduate degrees in Physics (BA in Theoretical Physics from the University of Bologna and an MSc in Theoretical Physics from the University of Turin). She has research interests in the economics of innovation, economics/science of science, and complexity. She has good teaching experience, including programming ("Coding in Python"). She has authored publications in physics and economics. Among the ones that are strictly relevant for the Call, there is a top-field publication (*Research Policy*). Also considering the academic age of the Candidate, it is notable that she has already been invited to present at international venues as prestigious as the NBER in Boston. The overall scientific profile and the research proposal are of very high quality, and congruent with the requirements.

### **CANDIDATE: KHAN Owais Ur Rehman**

The Candidate is a Postdoctoral Researcher at the Sant'Anna School of Advanced Studies. He holds a joint PhD in Management Innovation, Sustainability, and Healthcare (SSSA) and Environmental Sciences and Technology (Ghent University). He has undergraduate and graduate degrees in Applied Chemistry and Chemical Technology (University of Karachi), Political Science (MA, University of Karachi) and Environmental and Energy Management (MSc, University of Twente).

The candidate has limited teaching experience. He has authored several publications, but these are mainly outside the required disciplinary scope. Considering the qualifications, conference presentations and publications, the overall scientific profile is not sufficiently congruent with the requirements. The Candidate does not present a Research Proposal.

**CANDIDATE: RIOS IBÁÑEZ Vicente**

The candidate is Postdoctoral Researcher at the Department of Economics, Management and Quantitative Methods and the University of Milan. He holds a PhD in Economics from the Public University of Navarra, which was awarded in 2016. The Candidate has a BA in Economics from the University of Valencia, postgraduate qualification from the Open University of Catalunya, and an MSc in Macroeconomic Policy and Financial Markets from the Barcelona School of Economics. He shows good teaching experience and research interests spanning from spatial econometrics and regional economics (clearly the predominant interest) to environmental and energy economics, local development and public finance. The Candidate presents a rich portfolio of publications, some of which are placed in good, even though not top-field, outlets. There is robust evidence of participation at international conferences. The overall scientific profile is good. The research proposal, however, is of limited quality, narrow in scope, and not entirely congruent with the requirements of the Call.
